Expenditure Descriptions

Elementary Programs	Elementary schools instructional expenses which include salaries, benefits, supplies, repairs, etc.
Middle School Programs	Mickelson Middle School instructional expenses which include salaries, benefits, supplies, repairs, etc.
High School Programs	Brookings High School instructional expenses which include salaries, benefits, supplies, repairs, etc.
Other Regular Programs	Gifted, ELL, and Title I instructional expenses which include salaries, benefits, supplies, repairs, etc.
Special Programs	Special Education instructional expenses which include salaries, benefits, supplies, repairs, etc.
Student Support	Counseling, nursing, Curriculum, kindergarten screening, tech support and library expenses which include salaries, benefits, supplies, repairs, etc.
Instructional Staff Supp	Staff development which include salaries, benefits, supplies, travel, speakers, etc.
General Administration	Board of Education, election, legal services, audit services and superintendent expenses which includes salaries, benefits, supplies, services, etc.
Community Relations	District share for the 2nd school resource officer provided by the City of Brookings.
School Administration	Principal's office and Title I administration which include salaries, benefits, supplies, travel, dues and fees, etc.
Business/Operations	Business office, building operations, accreditation, recruitment and unemployment which includes salaries, benefits, supplies, repairs, advertising, utilities, etc. This also includes expenses for the Child Nutrition Fund, Enterprise Fund, Capital Projects Fund and Self Insurance Fund
Transportation	Transportation expenses for salaries, benefits, supplies, repairs, insurance, drug testing, etc.
Early Retirement	Payments to staff qualifying for early retirement.
Copy Machine Lease	Payments for the copy machine lease.
Debt Payment	Debt payments made out of Capital Outlay or Bond Funds.
Co-Curricular Activities	Boys, girls, activity transportation and combined boys/girls activities expenses for salaries, benefits, officials, travel and supplies.
Transfers Out	Transfers of cash to other funds.
